
Visible when transmitting a message.

### re Belt Clip To Install or Replace Batteries:

2. Pull up on the battery door latch to remove the battery compartment cover.

3. Insert three (3) AAA batteries. Position batteries according to polarity markings.

4. Replace battery compartment cover and belt clip.

. Do not mix old and new batteries.

. Do not mix alkaline, standard (carbon-zinc), or rechargeable (Ni-Cd, Ni-MH, etc.) batteries.
